

Z-MAN GAMES FACEBOOK SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER.

1. **HOW TO ENTER:** The **Z-Man Games Sweepstakes** (“**Sweepstakes**”) is an online-only Sweepstakes. Sweepstakes begins at 12:00:00 PM (CT) on 10/15/19 and ends at 12:00:00 AM (CT) on 11/01/19 (“**Promotion Period**”). To enter, eligible entrants will comment with a photograph of their entry on the related Sweepstakes post during the Promotion Period. All entries become the property of Sponsor. Limit one (1) entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Facebook accounts, or under multiple identities will be disqualified from participation in the Sweepstakes and all entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of Facebook account status, email address, and/or telephone number of entrants.

2. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of entry who are registered members of Facebook. Employees of Z-Man Games, its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, "Promotion Entities") and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply. Void where prohibited.

3. **WINNER SELECTION:** (2) winners will be selected in a random drawing to be conducted on or about 11/01/19, from among all eligible entries received during the Promotion Period from all methods combined by Sponsor or its designee, the judges in this Sweepstakes, whose decisions are final and binding.

Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, such potential winner will forfeit their prize and an alternate winner may be selected.
